Reservation Booking.com hybrid payment

With this new function, the guest can make the payment through the Booking.com website at the time of booking

If the client chooses to pay through Booking.com, with the different options offered on their website, Booking.com will send a virtual credit card so that the Hotel can make the corresponding charge to the amount of the reservation, at the moment of Check-in for reservations with Flexible rates, or at the same time to make the reservation with prepaid rates.

The invoice is issued in the customer's name

The client will still have the option to pay directly at the hotel

Process for paying the commission to Booking.com to will be the same as before.

Hotels of LATAM are excluded from this new function.
